Subject - Regarding Seat Allocation For The Academic Session (For 2019-20)

Sir/Madam,

In relation to the above mentioned subject, it is kindly informed that for the academic session 2019-20, the seat allocation for the subjects/courses being run in your college is conditional as follows-

Regarding seat allocation, it is to be informed that never take admission in those subjects/courses in which the teacher is not approved, and also do not take admission in those subjects/courses in which there is no affiliation in the academic session 2019-20. Otherwise, the college itself will be responsible and legal action will be taken by the University as per rules and the University will not conduct the examination of those admitted students.

Teacher approval letter related to the seat allotted by the university (in case of self-financed college/course/subject), list of current working teachers and photocopy of bank passbook related to salary payment to them through bank along with photograph, in every case, have to be submitted within 15 days of receipt of the letter. Do so. Otherwise, the university will not grant permission to fill the examination form, for which the college will be solely responsible. If the college has any objection regarding seat allotment by the university, then apply within 21 days along with the latest affiliation order of that subject / course, class operation, teacher selection approval, appointment letter, taking charge letter, contract letter and a photocopy of the bank passbook related to the latest salary payment. Otherwise, the college itself will be responsible.

If any error is found in the seat allocation done by the university, the university reserves the right to make amendments in it. The subjects / courses in the college for which temporary / permanent affiliation has been provided by the university in the academic session 2019-20. Ensure admission of students only after obtaining permission from the university to conduct classes for those subjects / courses for the academic session 2019-20. Otherwise, the college itself will be responsible for the admissions taken and action will be taken by the university as per rules and the university will not conduct examinations of those admitted students.
