ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the recognition was granted by NRC to Chandrakanti Ramawati Devi Arya Mahila P.G. College, Gorakhpur-273001, State – Uttar Pradesh for B.Ed. Course vide order No. F. NRC/NCTE/F-3/UP-1224/2005/4340-4348 dated 30.06.2005 with an annual intake of 100 seats with effect from 28th June, 2005.

3. AND WHEREAS, the institution Chandrakanti Ramawati Devi Arya Mahila P.G. College, Gorakhpur-273001, State – Uttar Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The institution shall identified/selected the faculty/staff and obtained the approval from the affiliating body for the same latest by 29th February, 2016 and same be conveyed to the Northern Regional Committee by that date.
- (iv) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (v) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Chandrakanti Ramawati Devi Arya Mahila P.G. College, Gorakhpur-273001, State – Uttar Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 29.02.2016.

6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act,

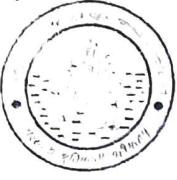

Sub: Your application seeking grant of recognition for B.Ed. course from the session 2004-2005.

Sir,

I am to inform that based on preliminary scrutiny of your application, with reference to Appendix IB of the National Council for Teacher Education (Form of application for recognition, the time limit of submission of application, determination of norms and standards for recognition of teacher education programmes and permission to start new course or training) regulations, 2002 dated 13 November 2002 and other regulations and guidelines published by NCTE from time to time, the following essential documents have not been submitted or not found as per the requirement of NCTE :

- Copy of approved building plan: (As per legal opinion- A blue print of the existing building, signed by the Architect Manager of the managing Society, but having no approval/sanction by the Local Authority is submitted. There is also no certificate as when the building is completed and constructions are made as per norms/by laws of the Local Authority.)
- LTC issued by local practicing lawyer in original: (Not Submitted.)
- A copy of the certificate of Registration, Memorandum of Association and Byelaws in case the institution is managed by a Society/Trust/Board: (Not Submitted.)
- Undertaking on non-judicial stamp paper to be submitted by a competent/authorized functionary representing the Management/institution after attestation by a notary: Undertaking duly signed by the authorized functionary, witnesses and affected by Notary is submitted. But it is as per old format while it ought to have been as per new format.
- A Sworn Affidavit verifying the contents given in the application form and the documents attached therewith. The affidavit must be attested through a First Class Magistrate/SDM/ADM.
- No objection certificate issued by State Govt. /UT administration in original: (Photo Copy of NOC has been submitted, the institution is required to submit original NOC.)

Under these circumstances, as per NCTE regulations dated 13.11.2002 and other Regulation in vogue vis-à-vis decision taken by the NRC in its 77th Meeting, your application cannot be processed for the session 2004-2005 & the same is carried forward for the session 2005-2006.

You are also required to provide, Registration No of the concerned Advocate issued by Bar Council of India who has signed the Land Title Certificate in your case, if it was not mentioned in your LTC.

Further, this is to inform you that the deficiencies as mentioned above may be complied with on or before 31st December, 2004, failing which your application will also not be processed for the session 2005-2006.
